
RESOLUTION DECLARING ADEQUACY OF PETITION OF MAPLE LANE AND MAPLE WOOD ADDITION AND REQUESTING SERVICE REGION BOARD TO PROVIDE SANITARY SEWER

WHEREAS, it is proposed to improve all real property adjacent to and abutting Highway 29 including the Maple Lane Addition, 1st Addition to Maple Lane, 2nd Addition to Maple Lane in the Northwest $\frac{1}{4}$ of Section 27, Township 129, Range 37; the Maplewood Addition in the Northeast $\frac{1}{4}$ of Section 26, Township 129, Range 37; all in Carlos Township of Douglas County Minnesota by sanitary sewer and to assess benefiting property for all or a portion of the cost of the improvement pursuant to Minnesota Statutes, Chapter 429.



1. The petition is hereby declared to be signed by the required percentage of owners of property affected thereby. This declaration is made in conformity to Minnesota Statutes, Section 429.035.
2. The Board of the Alexandria Lake Area Service Region consider the improvement of the above referenced property by the provision of sanitary sewer.
3. The township recommends this sanitary sewer improvement.
