
ADEQUACY OF PETITION DECLARATION - ORDER OF FEASIBILITY REPORT

WHEREAS: A petition requesting the improvement of road by bituminous surfacing has been received by the Carlos Township Board of Supervisors, said road being Carlos Bluff.


NOW, THEREFORE, BE IT RESOLVED, by the Board of Supervisors of the Township of Carlos, Douglas County, Minnesota, as follow:

1. The petition for improvement of the above identified road by bituminous surfacing, filed with the town Board on April 9, 2009, is hereby declared to be signed by the required percentage of owners of property affected thereby. This declaration is made in conformity with Minnesota Statutes, Section 429.035.
2. This Petition is hereby referred to Jeff Stabnow, acting under Agreement as Engineer for Carlos Township. He is instructed to report to the Town Board with all convenient speed advising the Town Board in a preliminary way as to whether the proposed improvement is feasible and as to whether it should best be made as proposed or in connection with some other improvement, and the estimated cost of the improvement as recommended.
3. Compensation for the Report shall be made on the basis of the hourly rates as presented by the engineer.
