CARLOS TOWN BOARD
June 22, 2017 – Carlos Elementary School

Board Members attending: Rod Meyers, Bill Krivanek, Dan Lehmkuhl, and Rebecca Anderson.

Guest attending: None

Chairman Meyers called the meeting to order at 7:00 PM with all reciting the Pledge of Allegiance.

Dan Lehmkuhl moved to approve the minutes of June 8, 2017 as printed. Bill Krivanek seconded the motion and it carried unanimously

Road issues: The board will take care of the thistles on the south end of Pike Road. In regard to rebuilding the ditch, the board will have Jeff Stabnow view the corner and make a suggestion to the board.

Joey Anderson has not submitted a bill to the board for cleaning out the tile on his property on Miltona Carlos Road. However, due to heavy rains, the area has filled in with topsoil.

Dan Lehmkuhl viewed the resident's property in Sailor Crossing. The boat and basketball hoop have been removed from the township right of way.

The clerk is to order a new sign for Pike Road. The board approved the order for a dead end sign on Woodsmen Drive by Byrne Reising's property.

Chris Tabbery has finished reshaping the culvert at the end of Woodsmen Drive. Dan Lehmkuhl viewed it and signed off on the project. He also will view the issue with the culvert that runs past the resident's driveway, as it is not working correctly. Mr. Tabbery is still going to remove rocks from his driveway.

The ditch on the west end of Carlos Timbers is being cleaned out by Mark Lee.

The clerk had emailed WSN to find out when Tolena Road/Bay Lane is expected to start. She had not heard back from them at the time of this meeting.

Chloride Application: Alden Just will begin this process in the next week or so.

Sealcoating/Crack fill: No word yet on when this will be started.

No parking sign have been requested on the corner /hill of East Lake Carlos Drive off of CR 42. The board will not be installing signs at this time.
